SECTION 4: First Aid Measures

EMERGENCY OVERVIEW

DANGER. Harmful if swallowed. Causes severe skin burns and eye damage. Harmful if inhaled.

Prevent runoff from entering drains, sewers, streams or other bodies of water. Absorb spill with inert material. Absorb unrecoverable product. Transfer contaminated absorbent, soil and other materials to containers for disposal.
