#### Suitable fire extinguishing media:

Use water spray, fog or foam.

#### Specific hazards arising from the chemical:

Highly flammable liquid. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of subsequent explosion. Gas may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back, causing fire or explosion. Runoff to sewer may create fire or explosion hazard.

#### Hazardous thermal decomposition products:

#### Specific fire-fighting methods:
